do everything she could to assist us. And it may seem minute to a lot of people, but to a person that has always despised authorities and considered them heartless; it was a paradigm shift to how I perceived law enforcement. I saw it as a message from God proving me wrong and it was truly a humbling moment that I'll never forget.

But what topped the whole event off, was the standing ovation that she received from my brothers and I after her impacting speech. And she continues to amaze me by coming back to PEP events time and time again. It's like she's become a part of our extended family and not just

an executive of the program, which is why we chose her as our "Executive of the Month" for January.
